#### **Riverland Energy Advises Members of Scam**


Riverland Energy would like to remind its members to not fall for scams. Members of the co-op report that they are being told they would be refunded \$50 for paying their bill on time, and will receive a discount on future bills. Another reported that he had overpaid on his bill and that the cooperative was refunding his money. In all cases, customers were asked to provide their bank information over the phone.

Riverland Energy employees will never request bank or payment information from members over the phone. Our member service representatives will only ask for information to identify who a member is.

**Never give your banking or personal information** over the phone to someone you did not call.

**Confirm before you act**: If you're contacted by someone claiming to represent Riverland Energy or another utility but you're unsure, just hang up the phone and call the utility directly. You can reach us at 800-411-9115 to verify the situation.

# Member rate adjustment necessary to meet increased costs

Our board and staff work continuously to keep costs as low as possible, but as we analyze the costs of providing you electric service, along with financial projections for the next few years, the cooperative recognizes a need to adjust rates.

Much like the increasing cost of the goods we purchase for our homes and family, the cost of the cooperative's materials and supplies used for our operations and maintenance have also increased. In December, our power supplier, Dairyland

Power Cooperative (DPC), announced a projected wholesale power base rate increase of 5.63 percent to electric cooperatives, effective January 2023. Wholesale power prices are the main driver to retail electric rates, as wholesale power is over 60 percent of our total expenses. A 5.63 percent base rate increase equates to an overall projected rate increase to Riverland Energy of 6.64 percent.

To cover this rate increase, in addition to increases in our costs to continue to maintain, grow, and improve the electric system into the future, we must adjust the rates to our members. Effective May 1, 2023, all members will see a 6.64 percent increase across the board. This is the first change in rates in three years.

The cost of electricity fluctuates based on things like weather, demand, and power plant outages. Each month, we evaluate the costs compared to the budgeted amount we need to run and maintain the cooperative. As a cooperative, we are a not-for-profit organization. This means that we charge you only enough to operate your cooperative. When the cost to purchase power is significantly more or less than anticipated, we pass a charge or credit onto our members. This is called a Power Cost Adjustment (PCA) and it's a direct pass-through of the actual cost of energy.

The PCA is a line item on your bill each month that reflects the charge or credit. In 2022, the PCA allowed us to return over \$1,000,000 dollars to our members as the cost of purchased power was lower than predicted. The PCA could fluctuate in 2023, but having the PCA is a benefit to members because adjustments can be made on an as-needed basis without continually adjusting electric rates.

The rate increase will appear on members' bills in June for the May usage. The 6.64 percent increase includes the energy charge (from \$.1208/kWh to \$.1285/kWh) and a \$.07 increase in the base service charge. The base service charge, currently \$1.18/day, will go to \$1.25/day. This base service charge is common among electric utilities; it helps utilities recover the fixed costs of the equipment, poles, wire, and transformers necessary to get power to members' accounts. All members pay this fee regardless of how much energy they use each month. The cost of these items has gone up considerably in recent years. All other rate classes will also be adjusted to reflect the rate increase.

I encourage you to peruse our website and publications, or give our office a call for some energy usage tips. We also offer a time-of-use rate that provides members with pricing that encourages you to lower usage during peak times, either by using less energy during on-peak times, or moving usage to off-peak times. Please understand Riverland Energy's Board of Directors and its management have the responsibility of ensuring that the cooperative operates as efficiently as possible and maintains a sound financial position. We all take that responsibility very seriously and we will make every effort to ensure that we limit any increase to you, our valued members, and will keep the cooperative financially sound.

# Support renewable energy through Evergreen

For as little as \$.65 per month you can support renewable energy without owning your own equipment through our Evergreen program. There's no limit on the number of blocks that can be purchased. You pay \$.65 for each block of 100 kilowatt-hours monthly.

The payments are used to cover the additional costs required to provide energy from renewable energy sources above and beyond the state requirements.


