With schools closing and restaurants limited to carry-out and delivery services only, dairy farmers have temporarily lost a huge market for the milk they produce. Some have had to dump large quantities of milk.

Through our statewide service agency, Wisconsin Electric Cooperative Association, we are offering a coupon for a free gallon of milk to all our members, redeemable at any Kwik Trip store. Simply clip out the coupon found in the June issue of the Wisconsin Energy Cooperative News and take it to Kwik Trip at any time from June 1 through July 16 for a free gallon of your choice of non-fat, 1%, or 2% milk.

And when you get back home and pour yourself and your family a cool glass of delicious, wholesome milk, raise a toast to your local dairy farmers who produced it.

Capital Credits to be returned in August/September

To help our members who are facing financial challenges during the COVID-19 outbreak, the Riverland Energy Board of Directors approved returning capital credits earlier than usual this year.

Current active members will receive a credit on their August or September bills. Anyone who has been a member of the cooperative between 1999 and 2017 will earn a refund. We will also retire accounts with \$35 or less remaining with the cooperative. Only inactive members will receive a check in the mail. The dollar amount returned depends on both the number of years of membership and how much energy the member has used.

Disconnect procedure

Riverland Energy temporarily suspended service disconnects during the "Safer at Home" order, but will continue at the end of May, disconnecting only those who have who have billing debt from 2019. Our disconnect procedure will resume as normal in June.

Be prepared for summer storms and power outages

Summer storms are always a threat. If you experience an outage, check to see that the power issue is not on your side of the electric meter. Check fuses and circuit breakers in your home.

When calling in an outage, please have this information available:

- Your account number
- Name on the electric account
- Service address where outage is occurring
- Phone number on the account
- Cause of outage if known

If you call after business hours or during a widespread outage our call center, Cooperative Response Center (CRC), will answer and assist you. During widespread outages, power is resorted systematically. Attention is given first to substations and main feeder lines, followed by individual members.

Outages can be reported through SmartHub or by calling 800-927-6206. View our outage map online at www.riverlandenergy.com to view current outages.

Home Energy Assistance for Utility Bills

In response to the COVID-19 crisis, the Department of Administration (DOA) has adjusted the eligibility requirements for residents who are seeking heating and electric assistance through the Wisconsin Home Energy Assistance Program (WHEAP).

Eligibility will now be based on the household's previous month of income, rather than the former requirement of the previous three months of income. This will allow those who are recently affected by the COVID-19 to receive assistance quickly.

Tips for managing energy use

If your family is at home more these days (working on computers, watching television, gaming, cooking, using more hot water, turning on lights, etc.), your electric bills may be higher than normal- especially the bill you'll receive this month which is based on May's energy use.


Families may need to be mindful of their energy use and consider adjusting certain habits to avoid higher costs. Simple money saving steps can help lower monthly electric bills without jeopardizing safety or comfort.

Recommended energy saving tips include:

- Program your thermostat to maximize energy savings. Setting your thermostat one degree lower when heating or one degree higher when cooling can reduce energy use by up to 5 percent.
- **Do full loads of laundry and wash with cold water.** Using warm water instead of hot can cut a load's energy use in half and using cold water will save even more.
- **Air dry dishes.** This step can cut your dishwashers energy use by up to 50 percent.
- Substitute LEDs for conventional light bulbs. Lighting can amount to up to 12 percent of monthly energy use. LED bulbs can cut lighting costs by 75 percent.
- Unplug appliances and electronics when not in use. Small appliances and electronics use energy even when not in use. When powered on, game consoles, televisions and similar electronics are responsible for up to 12 percent of energy use.

Monitor your usage through SmartHub

Monitor your usage with SmartHub, Riverland's free tool for account management. SmartHub can help you take control of your electric account and give you the chance to focus on smart energy choices for your household. You can view your actual usage by the hour, day, month or year and see how your usage is trending over time, which will allow you to take energyefficiency steps to lower your bill.



Access SmartHub at riverlandenergy.com and download the app on your mobile device through an app store of your choice — it's a free app. SmartHub can be easily accessed on your computer, phone, or tablet.
